## Contract

Please read carefully before signing

1. I accept for use the equipment listed on this form **AS IS** and I will be responsible for the replacement of the equipment loaned under this agreement at the equipment's full retail value, should any damage or loss occur due to my use of the equipment.
2. I agree to indemnify and hold harmless Ramstein Outdoor Recreation and the United States and its Agents for any loss, injury or damage, including any that results from claims or lawsuits for personal injury, death, or property loss and damage, resulting from my use of this equipment.
3. I agree to return all loaned equipment by the agreed upon time and in clean condition to avoid additional late charges or cleaning fees. Cleaning fees are equal to one additional day's rental.
4. I understand that there are inherent and other risks involved in snow skiing/snowboarding, the sport for which this equipment is intended to be used, and that the risk of injury is common and I freely assume that risk.
5. I understand and am aware that skiing/snowboarding is a **HAZARDOUS** activity. I understand the sports of skiing/snowboarding and the use of this equipment involve a risk of personal injury to any and all parts of my body. I hereby agree to freely and expressly assume and accept any and all risk of injury or death to the user of this equipment while using it.
6. I have made no misrepresentations to Ramstein Outdoor Recreation equipment checkout in regards to my height, weight, age and skiing/snowboarding ability.
7. All instructions on the use of this equipment have been made clear to me and I understand the function of this equipment. I agree that I will use this equipment solely for the purpose for which it was intended.
9. I understand and agree that ski-boot binding systems will not release or retain at all times or in all circumstances where release or retention may prevent injury, that it is not possible to predict every situation in which they will or will not release, and that their use cannot guarantee my safety.
9. I understand and agree that snowboard-boot binding systems are non-release and do not reduce any risk or injury while in use.
10. I agree that the binding release settings recorded on this form are the same as the setting numbers appearing in the visual indicators on the bindings.
11. Children 18 and under must have rental permission. **Party responsible for equipment if equipment user is 18 or under:** I represent that I am at least 19 years of age and that I am legally responsible for the user of this equipment and that I agree to be bound by the terms and conditions of this agreement.
12. **The Damage Waiver fee covers minor to moderate damage to the base of the skis/snowboard. The waiver excludes boots, core shots, damage to bindings, or equipment breakage, theft or loss. Extent of damage is up to the judgement of Ramstein Outdoor Recreation staff members, not the user. The cost for the Damage Waiver is \$1.**
